

SB60 - Georgia Bureau of Investigation Compliance

The **SB60** amendment to **O.C.G.A. § 10-1-395.5** requires Georgia secondary metals recyclers (SMRs) to verify the status of their business license and SMR registration.

If you report to LeadsOnline through a point-of-sale software via FTP or Web Service, you must log into www.leadsonline.com to certify that these items have not been suspended or revoked.

If you report directly through LeadsOnline, you will certify before uploading your daily transactions:

In compliance with **O.C.G.A. §10-1-353**, I certify that **Scrap 123 LLC** location has not had its business license or secondary metals recycler's registration revoked, suspended, or canceled in the previous year.

Certify and Continue

Decline (and Return to leadsonline.com)

SB60 also requires reporting of business-to-business catalytic converter purchase transactions to a Georgia Bureau of Investigation (GBI) database. There are three ways to submit your data:

1. Through your point-of-sale software via FTP or Web Service
2. By logging into LeadsOnline uploading a file
3. By logging into LeadsOnline and using Ticket Assistant


